

Team Simoco to Drive Continued Growth from ComGroup Acquisition

Acquisition of ComGroup further strengthens global market coverage and technology portfolio for radio communications specialist

13 July 2009 - Radio communications specialist Team Simoco has announced the acquisition of ComGroup Pty Limited to further strengthen its position in the global private mobile radio market and to drive continued growth.

ComGroup, the designer and distributor of Simoco branded professional mobile radio (PMR) terminals has been acquired by Team Telecom Group and will be merged with the existing operations of Team Simoco.

Located in Melbourne, Australia, and Andover, UK, ComGroup employs 101 staff and targets markets in Australia, North America and South East Asia. The acquisition complements Team Simoco's strong presence in European, Chinese and Latin American territories, and PMR base station and infrastructure design expertise.

ComGroup has recently developed digital radio technology, having launched a series of digital radio terminal products in 2009. This core technology will now be deployed to Team Simoco's base station products, accelerating the introduction of digital infrastructure products and enabling the combined company to offer a fully integrated portfolio of digital infrastructure, base stations and terminals.

Ian Carr, managing director at Team Simoco said: "The acquisition re-unites two businesses that share a 50-year heritage, common technology platforms and a global product brand. Whilst trading separately for the last six years, ComGroup and Team Simoco have retained structural links through an R&D joint venture, and bringing the two companies together heralds an exciting opportunity for innovation, product development and growth into new markets and territories."

Mike Norfield, managing director of Team Telecom Group added: "The combined company will continue to trade as ComGroup and Team Simoco in their respective territories, reflecting our intent to listen to customers and to focus on business continuity whilst offering enhanced product choice and access to new digital technologies. In addition to fast tracking of digital

products, the acquisition will unify our respective infrastructure and terminal portfolios under the Simoco brand and combine our channels to give us truly global reach.

The acquisition of ComGroup also includes Dalman, a manufacturer of simulcast and voting technologies. Dalman already supplies its products through Team Simoco and ComGroup channels and its products will bring further depth to the Simoco portfolio.

Further opportunities exist to leverage competitive advantage, as a result of both increased market share and economies of scale in operations and manufacturing, through ComGroup's established facilities in the Far East.

Neil Walsh, director of ComGroup said: "This is an exciting time for everyone associated with Team Simoco and ComGroup. The combined company will bring cutting-edge technologies and products and create new opportunities for dealers and customers alike."
